The Stewards, having received a report from the FIA Technical Delegate, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts On Sunday 15th March 2026 at RZ10 – WRTI Naivasha, while car No.46 was inside the refuelling area and at the end of the refuelling process, one of the team members of the competitor of car No. 46 gave some material to the crew of car No. 46.

Offence Art. 2.15 and Art 61.2.1 of the 2026 FIA WRC Sporting Regulations

Decision **Disqualification** of Competitor of Car No. 46 from the event

Reason A hearing was held on Sunday 15th March 2026 at 17.15, in the presence of the driver, the co-driver and the Team Manager Mr. Felix Mururu. Video evidence was shown to them.

The Driver explained that the previous day they had some concerns due to some water entering into the car because of the heavy rain. For this reason, they had asked their team members to give them some tape to fix the problem. However, they stated that they had not used what was given to them.

Art. 2.15 of the 2026 FIA WRC Sporting Regulations defines "The use or receipt by the crew of any manufactured materials (solid or liquid, unless supplied by the organisers), spare parts, tools or equipment other than those carried in the competing car or the presence of team personnel as defined in Art. 56.2."


Art. 61.2.1 of the 2026 FIA WRC Sporting Regulations clearly stipulates that "Only actions inside a RZ directly involved in the refuelling of the competing vehicle are permitted".

The Stewards therefore concluded that the crew of car No.46 was in breach of the above regulations and that the penalty imposed is proportional to this serious infringement.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2026 FIA International Sporting Code and Chapter 5 of the 2026 FIA Judicial and Disciplinary Rules.
