The Stewards having received a report from the Clerk of the Course, Doc 3.4, having examined video evidence, heard the Crew Members, Ihab Al-Shurafa and Ahmad Jankhout, having considered the matter, determine the following:

Fact:

A Mitsubishi Pajero with the Plate Number 44-31974 was seen driving in Stages SS1/4 Tal Hilali and SS9/12 Wadi Nar on Friday 23rd, May 2025, and the owner of the car is the driver, Ihab Al-Shurafa.

Offence:

Breach of Article 35.3 of the FIA 2025 RRSR.

**Decision:** 

To impose a fine penalty of €1500 (one thousand five hundred euros) on Competitor/Driver Ihab Al-Shurafa.

€500 (five hundred euros) to be paid within 48 hours of their notification.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <a href="https://fiafines.fia.com">https://fiafines.fia.com</a>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

€1000 (one thousand euros) of which is applied with suspension of sentence until 31/12/2025 subject to no further breach of similar nature committed by the Competitor/Driver during this period.

Reason:

During the hearing, the driver admitted that he was the person driving the vehicle through Stages SS1/4 Tal Hilali and SS9/12 Wadi Nar on Friday 23<sup>rd</sup> May, 2025. He explained that he did not know that the road was part of the stages until that date Maps and Rally Guide was not published. The names of the stages were published in the Supplementary Regulations on 22<sup>nd</sup> April, 2025 and reflect the real geographic location of the stages. Also, the Crew Members have not asked the organizers for permission to be on the stages outside the reconnaissance time.

The Stewards, after due deliberation, conclude that the driver of Car No. 7 was in breach of Art. 35.3 of the 2025 FIA Regional Rally Sporting Regulations.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
