The Stewards having received a report from the COC, Doc 3.9, with a report from the Refueling Officer, with photo evidence, having heard the team representative and crew members, having considered the matter, determine the following:

Fact: A car with the Service Sticker of Car No. 7 was seen at the Refueling Zone with a team member smoking

a cigarette parked less than 10 meters away from the fuel tanks.

Offence: Breach of Article 12.2.1.h of the FIA 2025 ISC.

Decision: To impose a fine penalty of €250 (two hundred fifty euros) on the Competitor No. 7, Ihab AL-SHURAFA.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <a href="https://fiafines.fia.com">https://fiafines.fia.com</a>. Any delay in

making payment may entail Suspension during the period a fine remains unpaid.

Reason: The Stewards conducted an investigation. During the hearing, the Refuel Officer stated that he asked the team member to stop smoking in the refueling zone but the team member did not adhere and

continued smoking in his car that was parked less than 10 meters away from the fuel tanks. After the hearing with the team representative and crew members, they acknowledged the issue that they are

responsible for all their team members (Article 9.15.1 of the FIA 2025 ISC.)

Smoking in the Refueling Zone is prohibited and there was a relevance sign placed at the start of the refuel zone. Safety remains a key challenge and the FIA is committed to avoid unsafe actions that might result in hazardous situations

The decision is based on Article 11.9.1, Article 11.9.3.a, Article 11.9.3.f, Article 9.15.1, and Article 12.2.1.h of the FIA 2025 ISC.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
