The Stewards, having received a report from the Race Director / Clerk of the Course concerning following facts:

OVERTAKE OTHER CARS OUT OF TRACK

Determine the following:

according to Art. 11 & 12 ISC, after considering the matter and all available evidence, determined that a breach of the rules has been committed by the competitor referred, therefore decided to inflict the penalty indicated below:

- Reprimand (Art. 14.5 SR)
Cancellation of: lap time of infringement, fastest lap time in session
Cancellation of all lap times in session, up to hrs
Time penalty of 10 seconds
Drive-through penalty / If it is imposed during last minutes or at the end of Race 25 sec. will be added.
Stop-go penalty of seconds / If imposed during last minutes or at end of Race 35 sec. will be added.
Black flag
Other

Reason:

- Crossing the white line at pit lane entry exit (Art 20.9 SR)
Exceeding the speed limit in the pit lane: speed km/h (Art 20.5 SR)
Not respecting yellow flag repeatedly (Art 13.7, 20.25 SR)
Not respecting track limits repeatedly (Art 20.16 SR)
False start entry Badly positioned (Art 32.14 SR) Jump Start (Art 32.17 SR)
Falling to follow the official instructions (Art 14.2 Sport Regs)
Driving through a red light at the end of the pit lane Practice/Quali (29.6SR) Formation (32.4SR) Race (33.2SR)
Causing a collision (Art 14.2, 20.12, 20.17, 20.18 SR)
Forcing a driver off the track (Art 14.2, 20.12, 20.17, 20.18 SR)
Illegitimately impeding another driver (Art 14.2, 20.12, 20.17, 20.18 SR)
Being less time in the controlled area that allocated time for handicap / stop & go (Art 14.10SR)
Other OVERTAKE OTHER CARS OUT OF TRACK

Competitors are reminded that they have the right to appeal certain decisions of the Stewards (art. 15 Int'l Sporting Code). According to art. 12.3.4 ISC and art. 14.5c Formula Winter Series Sporting Regs. this penalty is not susceptible to appeal. According to art. 12.3.3.b ISC this Decision becomes immediately binding even in case of an appeal.
