The Stewards, having received a report from the Race Director / Clerk of the Course concerning following facts:

PRACTICE START DURING RECONNAISSANCE LAP

Determine the following:

according Art. 11 & 12 ISC, after considering the matter and all available evidences, determined that a breach of the rules has been committed by the competitor referred, therefore decided to inflict the penalty indicated below:

- Reprimand (Art. 14.5 SR) \_\_\_\_\_

### Reason:

- Crossing the white line at pit lane  entry  exit (Art 20.9 SR)
- Exceeding the speed limit in the pit lane: speed \_\_\_\_\_ km/h (Art 20.5 SR)
- Not respecting yellow flag  repeatedly (Art 13.7, 20.25 SR)
- Not respecting track limits  repeatedly (Art 20.16 SR)
- False start  entry Badly positioned (Art 32.13 Sport Regs)  Jump Start (Art 32.16 SR)
- Falling to follow the official instructions (Art 14.2 Sport Regs)
- Driving through a red light at the end of the pit lane (Art 14.2 Sport Regs) (Art 29.6 SR)
- Causing a collision (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Forcing a driver off the track (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Illegitimately impeding another driver (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Being less time in the controlled area that allocated time for handicap / stop & go \_\_\_\_\_ (Art 14.10SR)

Other Art. 2.4 OF RACE DIRECTOR EVENT NOTES

Competitors are reminded that they have the right to appeal certain decisions of the Stewards (art. 15 Int'l Sporting Code). According to art. 12.3.4 ISC and art. 14.5c F4 Spanish Championship Sporting Regs. this penalty is not susceptible to appeal. According to art. 12.3.3.b ISC this Decision becomes immediately binding even in case of an appeal.
