



- False start entry Badly positioned (Art 32.14 SR) Jump Start (Art 32.17 SR)
- Falling to follow the official instructions (Art 14.2 Sport Regs)
- Driving through a red light at the end of the pit lane Practice/Quali (29.6SR) Formation (32.4SR) Race (33.2SR)
- Causing a collision (Art 14.2, 20.12, 20.17, 20.18 SR)
- Forcing a driver off the track (Art 14.2, 20.12, 20.17, 20.18 SR)
- Illegitimately impeding another driver (Art 14.2, 20.12, 20.17, 20.18 SR)
