Cutting off engine in fast lane

Determine the following:

- Falling to follow the official instructions (Art 14.2 Sport Regs)
- Driving through a red light at the end of the pit lane (Art 14.2 Sport Regs) (Art 29.6 SR)
- Causing a collision (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Forcing a driver off the track (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Illegitimately impeding another driver (Art 14.2, 20.12, 20.17, 20.18 Sport Regs)
- Being less time in the controlled area that allocated time for handicap / stop & go _____ (Art 14.10SR)
