The Stewards, having received a report from the Clerk of the Course FIA Technical Delegate, with video evidence attached, summoned the above competitor's representative as well as the driver and the co-driver (summon No.2), have considered the following matter and determine the following:

- Fact: On Saturday 5<sup>th</sup> April 2025, Car No. 27 performed a dangerous manoeuvre (weaving) on the road section N432 to SS 2.
- Offence: Breach of Art. 34.3.1 of 2025 FIA Regional Rally Sporting Regulations
- Decision: Fine of 250 € on the Driver of Car No. 27 Norbert HERCZIG

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <u>https://fiafines.fia.com</u>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:** The Competitor, as well as the crew members, were informed accordingly by the Stewards and were given the possibility, if they wished, to bring forward any representations.

They informed that they would not make any further representations.

The Stewards examined the video evidence available, which shows Car No.27 weaving between the two lanes moving on national road N432 without crossing the solid white line.

The Stewards, after due deliberation, conclude that the driver of Car No. 27 was in breach of Art. 34.3.1 of the 2025 FIA Regional Rally Sporting Regulations, which explicity mandates that the crew must observe the national traffic laws, and imposed the above fine under Art. 34.3.4 a) of the 2025 FIA Regional Rally Sporting Regulations.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
