The Stewards, having received a report from the FIA Technical Delegate, summoned the above competitor's representative (summon No.1), have considered the following matter and determine the following:

- Fact: Competitor No. 2 failed to submit the FIA Technical passport during pre-event scrutineering
- **Offence:** Breach of Art. 251.2.1.8 of Appendix J of the 2025 FIA International Sporting Code Breach of Art. 11.1.1 of the 42 Rally Sierra Morena – Còrdoba Patrimonio de la Humanidad Supplementary Regulations

Decision: Fine of 500 € on the Competitor of Car No. 2 MIKO MARCZYK

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <u>https://fiafines.fia.com</u>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:** The Stewards heard from the Team Representative, Mr. Marcis Kenavs, and from the Team Owner, Mr. Gergely Topp, of car No. 2, on Thursday 3<sup>rd</sup> April 2025 at 11:00.

The Team owner explained that when preparing for the event they noticed that the FIA Technical Passport was missing and they probably lost it during the last event of the last season. They, then, contacted the FIA Technical Delegate that informed them that he will submit the matter to the Stewards.

As per Article 251.2.1.8 of Appendix J of the 2025 FIA International Sporting Code, it is a requirement for all Competitors to present the FIA technical passport during pre-event scrutineering to ensure compliance with the technical and safety standards. This failure to submit the required document is a breach of the above-mentioned regulations and of Art. 11.1.1 of the rally's Supplementary Regulations, which outlines the obligation to provide all the documents.

The Stewards, therefore, concurred that non-compliance with these regulations compromises the integrity of the scrutineering process and decide that the penalty imposed is proportional for this offence.
